## **Draft Strategic Document**

#### **Introduction**

The Fifth Summit was proposed by the Government of Haiti in consideration of the fact that the fourth one had been held in July 2005, that is to say seven years ago. They were of the view that this would have led to a progressive weakening of the organization and the gradual reduction of the dynamic interaction which should exist among member countries. Also in light of the current world scenario and challenges, it was felt that the time had come to establish a new vision and plan of action, fully supported and approved by Heads of State and/or Government. Political dialogue would take place with regard to the founding vision of the ACS, as well as a stronger and more integrated Greater Caribbean region, with a view to taking concerted action in this respect.

In addition to the areas of work currently addressed by the Association, the Government of Haiti held the view that climate change, food security, promotion and conservation of the cultural patrimony of the Greater Caribbean, education, science and technology were also areas in which synergies should be strengthened. The solidarity of Member States towards its fellow Member, Haiti, should also be reaffirmed.

#### **Overview**

I Summit 1995 - Port of Spain

Purpose: Declaration of Principles and Plan of Action on Tourism, Trade and Transportation

This Inaugural Summit expressed political consensus on cooperation in the three areas afore-mentioned, with a view to creating an extended Greater Caribbean economic space.

#### II Summit 1999 - Santo Domingo

<u>Purpose</u>: Analyze the progress of the ACS from 1995 to 1999 so as to determine the projection of the Caribbean Region towards the 21<sup>st</sup> Century. This Summit analyzed the progress made and outlined a medium to long term strategy to promote functional cooperation and concerted action. It laid the institutional foundations and consultation was forged among the stakeholders. Emphasis was placed on co-operation in culture, education, science and technology.

#### III Summit 2001 - Margarita Island

<u>Purpose</u>: Strengthen the ACS as forum for consultation, concerted action and cooperation towards the promotion of a Caribbean identity.

It was agreed that the main mission of the Association hence, would be the establishment of the Greater Caribbean as a Zone of Cooperation, an extended economic space, strengthening cooperation in the four priority areas, viz. trade, sustainable tourism, transport and natural disasters. The Convention on the Sustainable Tourism Zone was signed.

#### IV Summit 2005 - Panamá

<u>Purpose</u>: To reflect on the evolution of the organization; its achievements and challenges; to focus on its future, with a view to giving a new political impetus to the Association.

## **The Way Forward- Sustainable Tourism**

- Expedite the Entry into Force of both the Convention Establishing the STZC, and the Protocol to said Convention.
- To hold the III Meeting of Ministers of Tourism of the ACS (TMM-3) in 2013 under the theme "Enhancing the Global Competitiveness of the Regional Tourism Industry through the Sustainable Development of Niche Markets".
- Operationalisation of the institutional structure of the CPLC to include formalisation of Agreements with the Centres of Excellence. Concurrently, development of mechanisms to secure the sustainability, profitability and international recognition of the CPLC program.
- Development of activities to advance and promote the cultures of the Greater Caribbean.
- Development of initiatives for research, networking and dialogue on Multi-Destination Tourism.
- Implementation of knowledge-sharing and capacity-building activities in the area of Policing and Disaster Preparedness as they relate to Visitor Safety and Security.
- To take a decision with regard to Cruise-ship Tourism Initiatives.

#### The Way Forward- Disaster Risk Reduction

- Reiterate Mandate 20d of the IV ACS Summit to foster international cooperation and capacity-building in the area of natural disasters, in enhancing the provision of humanitarian assistance at all states of a disaster, and in promoting a culture of prevention of early warning systems.
- It is important that the Committee on Disaster Risk Reduction continue the implementation of the Saint Marc Plan of Action.
- Include in Plan of Action topics related to the Reduction of Disaster Risk through education and training both formal, and informal (Point 14 of the Saint Marc Plan of Action).
- Also include in POA, the transversal integration of gender in the policies, plans and actions regarding disaster risk reduction (Point 6, Saint Marc Plan of Action).
- In addition, strengthen international cooperation especially at the regional level instances dedicated to disaster risk reduction.

#### The Way Forward-Transport

- To encourage more Members to ratify the Air Transport Agreement.
- To formulate a questionnaire to be distributed among member states who have ratified the air transport agreement to get feedback as to the impact of said Agreement.
- It is imperative that the Association dedicate efforts and consider the urgent need for a general aviation policy for the Greater Caribbean, which would establish a judicial framework and cooperation, while ensuring the highest levels of security in international civil aviation.
- To continue with the initiative "Maritime Routes of the Greater Caribbean" so as to identify and compile information in respect of the maritime routes in existence.
- To promote the Initiative, and to attract financing.
- To recommend the incorporation of cruise-ship routes and internal flights.
- To identify strategies to reduce administrative and judicial barriers to transport.

## 2.0 AN AGENDA FOR THE SUMMIT: THE GRAND THEMES

We are cognisant of the need to arrive at the Summit with clear objectives and projects, producing tangible results and having a social impact. Additionally, it is important, on that basis, that the Heads of State give their full support to a work agenda, which would lead to the revitalisation of the ACS as a great instrument in promoting dialogue and cooperation among the Member States, in accordance with our mandate as a forum for consultation, concerted action and cooperation.

An evaluation of the programmes and projects recorded at the last Summit of Heads of State of the ACS, held in Panama in 2005, enables us to present the following conclusions as key elements in drafting an Agenda for the next Summit, to be held in Haiti in April 2013:

- The key areas established to foster cooperation and dialogue among ACS Member Countries, namely Sustainable Tourism, Development of Trade and External Economic Relations, Transport and Disaster Risk Reduction, remain in full force. However, it is necessary to undertake a thorough revision of their programmes in order to strengthen the initiatives that have produced results and incorporate others whose relevance today is acknowledged by all. In this regard, the issue of climate change, under the Directorate of Disaster Risk Reduction; Food Security under the area of Trade and, of no less importance, the integration of a gender perspective as a crosscutting element in all ACS programmes, should be taken into account.
- It is necessary to **revisit the area of the Protection of the Greater Caribbean Cultural Heritage**, as well as Cooperation in Education, Science and Technology. At the very inception of the ACS, and during its subsequent development, particularly at the Second Summit of Heads of State, great emphasis was placed on this issue, which was later relegated to the background or completely disappeared. In the Convention Establishing the Association of Caribbean States in 1994, the very first paragraph of the Preamble stated that Contracting States were:

Committed to initiating a new era characterized by the strengthening of cooperation and of the cultural, economic, political, scientific, social and technological relations among themselves.

We do not believe, in principle, that there is a need to establish a new Directorate. The Secretariat commits to making all the necessary efforts to develop mechanisms for cooperation among the Ministries of Culture, as well as among academic institutions.

- 3) It is crucial that we **arrive at the Summit with definite and tangible ACS work projects**. In this regard, we propose the following:
  - 3.1) Strengthen mechanisms for cooperation and dialogue between the ACS and Founding Observer Organizations (CARICOM, SICA, SELA, SIECA, CTO, UNECLAC) as well as other regional organisations such as OECs, CELAC, and others. To this end, meetings are being planned in the first instance with the OECS,

CARICOM, SICA and CELAC, and with a view to arriving at the Summit with concrete work programmes in the process of being executed.

- 3.2) Work on a **large macro project** geared toward creating jobs in the area of microenterprises, from a gender perspective. Basically, the intention is to create a comprehensive strategy that would strengthen microenterprises led by women, having a great social impact on the fight against poverty, specially designed for Haiti.
- 3.3) Work on a **concrete project to strengthen the Caribbean Sea Commission** based on the following concepts: i) build pragmatic objectives in the short, medium and long term. In this regard, we should begin by promoting the role of the Commission as a coordinating body for dialogue and cooperation among stakeholders working toward the preservation of the Caribbean Sea, while pursuing efforts to have it declared a Special Area. ii) Design a strategy that would lead to the acquisition of the budget required for the functioning of the Commission, through more systematic approaches to donor countries and international institutions.
- 3.4) **Strengthen the strategy of the Special Fund.** In order to achieve the objectives of the ACS, it is absolutely necessary that the Special Fund be revitalised as a preferred mechanism for the mobilisation of funds for cooperation projects and dialogue among Member States. The policy of funding the hiring of officers for the Fund with the support of the countries has not worked well. It has not allowed for stability and consistency in the development of a strategy. What is more serious is that today, we have had no officers attached to the Fund for more than one year. It is thus crucial that the Secretariat assume the cost of hiring a Manager for the Fund from its own budget.
- 3.5) Strengthen the role of ACS Associate Members and Observer Countries towards a greater synergy and participation, which will enable us to achieve our objectives as we would be in a position to increase the level of cooperation and dialogue in the region.
- 3.6) **Strategic projects** that have been duly approved by the Special Committees, some of which have guaranteed funding and others a high probability of being funded, should occupy a prominent place on the agenda. These include: a) the project Strengthening Hydro-meteorological Operations and Services in Caribbean SIDS known as SHOCS, b) the Map of Maritime Routes of the Caribbean Project, c) the Maritime and Port Strategy, d) the Sustainable Tourism Zone of the Caribbean and e) the Business Forum of the Greater Caribbean.
- 4) Finally, it is necessary **to reflect** on the possibility of giving instructions to the Ministerial Council so that Ministers may revise at the most opportune and appropriate moment, the matter of the ACS Budget and quota assignations, bearing in mind the preponderance, relations and commitments to be forged by the ACS in light of these new directives.
