**ACCESSION TO THE CONVENTION FOR THE ESTABLISHMENT OF THE  
SUSTAINABLE TOURISM ZONE OF THE CARIBBEAN**

**RATIFICATION DEFINED**

Ratification is "the international act so named whereby a State establishes on the international plane its consent to be bound by a treaty"<sup>1</sup>. The rationale for ratification is to provide negotiating states with time, before giving their consent to be bound, following the adoption and signature of a treaty. In some cases the treaty may require legislation; or the constitution of the state may require parliamentary approval of the treaty or the state may simply require time to consider the implications of the treaty.

The requirement of ratification to establish the consent of a state to be bound is provided for within the text of the treaty. Thus for example, the Association of Caribbean States *Convention for the Establishment of the Sustainable Tourism Zone (STZC Convention)* at Article 7 stipulates that:

"This Convention shall be subject to ratification by the signatory States, Countries and Territories mentioned in Article IV of the Convention Establishing the Association of Caribbean States, in accordance with their respective constitutional procedures".

Whether and when ratification will bring the treaty into force for the state will depend on the provisions of the treaty. Accordingly, Article 9 of the STZC Convention provides that:

"This Convention shall enter into force on the thirtieth day counted from the date on which the fifteenth instrument of ratification is deposited".

Therefore the STZC Convention requires fifteen states to deposit instruments of ratification before the treaty enters into force.

**ACCESSION DEFINED**

**ACCESSION** is another means whereby a State consents to be bound by a treaty. Specific provision for this form of consent must be made in the treaty. Thus, Article 8 of the Convention for the establishment of the Sustainable Tourism Zone of the Caribbean provides that:

"After the deposit of the fifteenth instrument of ratification, this Convention shall remain open to accession by any of the States, Countries and Territories referred to in IV of the Convention establishing the Association of Caribbean States".

Consequently, upon the receipt of the fifteenth instrument of ratification and the entry into force of the Convention, consent to be bound by the Convention will be established through accession.

## **Accession to the STZC Convention**

### **THE PROCESS OF ACCESSION**

Accession, like Ratification consists of firstly the execution of an Instrument of Accession, followed by the lodging of the instrument with the depositary (multilateral treaty).

#### ***Execution of the Instrument of Accession***

An instrument of ratification must give clear and unambiguous expression to its intention to be bound. The instrument must therefore:

1. Identify the treaty by its title, the date and place the treaty was concluded;
2. Give the name and title of the person signing the instrument;
3. State when and where the instrument was issued. (Example attached in **Appendix 1**)

The instrument of accession is to be signed on behalf of the state by either the Head of State, Head of Government or Foreign Minister depending on the constitution and practice of the state. If another person signs, full powers granting authority to that person to do so will need to be produced.

Upon execution, the instrument is sent along with a Note Verbale to the Office of the Director of International Legal Matters, Ministry of Foreign Affairs, Colombia. This office will subsequently notify the Association of the deposit of the executed instrument (contact information as indicated in **Appendix 2**).
